What should you do if you suspect	that a child is being abused?
Call the proper authorities immediat	ely. If you suspect a child is being abused, you should contact your local child abuse hotline. Generally
the telephone number to report child	abuse is listed in the white pages under "child abuse". If you suspect a child is in immediate danger, the
local police agency should be contact	sted first. If the suspect is a volunteer, student or instructor of an ATA school or club, notify
Headquarters AFTER the police have	e been notified.
How do I know what my reporting	responsibilities are?
People are often concerned about be	ing sued for reporting child abuse. You are not required to know for certain that a child has been abused.
